

RULE NO. 18

NON-STANDARD METER

The Company shall designate a certain type of meter as its standard meter ("Standard Meter") for common use.¹

Non-Standard Meter Set-Up Charge

Any customer may elect to have its existing meter removed and replaced with a non-Standard Meter ("Non-Standard Meter"). To make this election, the account holder or the account holder's properly designated representative must properly complete and submit to the Company the form attached to this Rule No. 18 as Exhibit A ("Non-Standard Meter Form"). If a customer with multiple accounts elects to have its existing meter removed and replaced with a Non-Standard Meter for more than one account, a separate Non-Standard Meter Form must be properly completed for each respective account and submitted to the Company.

The following sets forth the Non-Standard Meter Set-Up Charge, by meter type, that shall apply for each meter removed and replaced with a Non-Standard Meter pursuant to a Non-Standard Meter Form properly completed and submitted to the Company after November 3, 2013:

<u>Type of Non-Standard Meter to Replace Removed Meter</u>	<u>Non-Standard Meter Set-Up Charge</u>
Residential Basic Meter	\$50.64
Residential Bi-Directional Meter	\$50.64
Commercial Basic Meter	\$65.64
Commercial Bi-Directional Meter	\$138.80

Following the Company's (i) receipt and verification of a properly completed Non-Standard Meter Form, and (ii) receipt of the applicable Non-Standard Meter Set-Up Charge, the Company will remove the existing meter for that customer account and replace it with a Non-Standard Meter. The Company shall provide and select the appropriate type of Non-Standard Meter for that customer account.

By completing and submitting a Non-Standard Meter Form, the respective customer agrees and understands that such customer will not receive the benefits of a Standard Meter.

¹ The Company may designate a different type of meter as its Standard Meter from time to time. The Company's Standard Meter as of September 30, 2013 is an advance solid state meter with two-way communication.

Monthly Non-Standard Meter Charge

Each customer that has a Non-Standard Meter shall be subject to and shall pay a monthly charge of \$10.27 per Non-Standard Meter.

Election to Use Non-Standard Meter Form

(use separate form for each account)

I, a customer of Kauai Island Utility Cooperative (KIUC), hereby elect to have KIUC (1) remove the meter currently installed in connection with my below-listed account, and (2) replace such meter with a "Non-Standard Meter" (as that term is defined in Rule No. 18 of KIUC's Tariff No. 1).

By completing and submitting this form, I understand and agree that: (a) I will not receive the benefits of a "Standard Meter" (as that term is defined in Rule No. 18 of KIUC's Tariff No. 1), and (b) I am responsible for paying the then applicable Non-Standard Meter Set-Up Charge, as well as any monthly charges, set forth in Rule No. 18 of KIUC's Tariff No. 1, as the same has been or may be amended from time to time.

I also understand and agree that I am responsible for providing and maintaining monthly access to KIUC for purposes of meter installation, maintenance, and reading. Failure to provide and maintain access to KIUC will result in my service being terminated pursuant to Rule Nos. 7A, 7D, and 14G of KIUC's Tariff No. 1.
